
Annual Report Carn Brea Parish Council



Carn Brea Parish Council

Carn Brea Parish Council operates at the most local level of Local Government with 16 Councillors elected for a term of four years. The Councillors work for the Parish in a voluntary capacity and are supported by a team of paid staff headed by the Parish Clerk, Sarah-Jane Noakes.

The Parish Council is always interested in the views of our local residents. Please feel free to contact us, via the Clerk, by telephone, e-mail or by calling into the offices.

The Parish of Carn Brea, also known as the electoral area of Illogan South, lies between Redruth Town and Camborne Town and is made up by the areas of Pool, East Hill, Illogan Highway, West Tolgus, Barncoose, Carn Brea Village, Piece, Carnkie, Tregajorran, Treskillard, Four Lanes, Pencoys and part of Brea.

Membership of the Council

The Council consists of sixteen Councillors. There are 4 Councillors in Barncoose Ward, 1 in East Hill Ward, 5 in Four Lanes Ward, 5 in Pool Ward and 1 in Tolgus Ward. Contact information can be found on notice boards within the parish or on our website:- www.carnbreaparishcouncil.gov.uk

Electorate

The number of electors in the Parish is currently 6626.

Council Owned Land

The Council owns approximately 22 acres of land. This is made up of a park at Wheal Fortune, heath at Carn Brea Hill, St Euny Well and Treloweth Open Space.

The Bassett Monument on Carn Brea is maintained by the Council on a lease from Cornwall Council.

Committee Meetings

The Parish Council conducts its business through a committee system.

The **Full Council** meets monthly on the third Thursday of the month. All meetings start at 7 pm and the public are invited to attend.

The **Planning Committee** meets monthly on the last Thursday of the month, again at 7 pm and the public are invited to attend.

Other Committees meet less frequently and are the Amenities and Projects Committee, Health & Safety and Finance Committee and the Staffing Committee. All these meetings are generally held on Thursdays and at 7 pm. The public are invited to attend these meetings.

Meetings do not take place during August, except for the Planning Committee.

At most meetings the public are invited to attend and an opportunity is provided for Registered Electors of the Parish to speak on agenda items. There may be times in a meeting where the business is conducted in private with the public and press excluded. The public speaking part of a meeting it generally limited to 20 minutes. The remainder of a meeting is discussion by the Councillors only.

Grant Aid





The Council has a policy to encourage a community spirit in the Parish. Carn Brea Parish Council were delighted to award a grant of £400 to the Cornwall Animal Hospital in Treleigh. The charity currently serves over 3,500 clients, covering 2/3 of Cornwall and providing quality care for all animals, regardless or wealth or income. Whist the hospital currently offers a wide range of care, it plans to become a centre of excellence that can provide all the services an animal could need. Their exciting plans include a hydrotherapy pool, treadmill and space for veterinary training and they hope to complete the new building by the end of 2020.

Pool in Bloom



The Pool in Bloom scheme once again brightened the main road through Pool and received many compliments from local residents.

Devolution

Discussions have taken place with Cornwall Council in respect of the devolution to Carn Brea Parish Council of a number of local assets, including parks, open spaces, and monuments.

Parish Newsletter and Website

The Council strives to improve the dissemination of information to the local residents and the Parish Newsletter is a permanent quarterly publication. The website provides information on forthcoming events e.g. Gardening Competition, Remembrance Service and Carol Concert. Councillor information, contact details, agendas and minutes from meetings are available on the site.

Planning Committee

Over the period January 2018 to December 2018 the Planning Committee has considered a total of 72 applications in its role as a statutory consultee on behalf of the parish. The Committee supported 42 applications and objected to 27 applications. The committee was unwilling to consider 1 application due to lack of clear and required information. The committee neither supported or objected to 1 application and deferred 1 application due to awaiting amended plans.

Community updates

Spring/autumn bulbs have been planted in various areas in the Parish to bring a splash of colour into the community.

The Council is pleased to report that it has acquired the red ex-BT telephone kiosk at Carn Brea Village, renovated it, and installed shelving and a Community Book Share service. This facility joins our earlier Book Share in the red telephone kiosk outside The Countryman Public House at Piece. Thank you to those who have donated books to the Council.

Police Liaison

The Council has attended each of the Police Liaison Meetings held during 2018. The meetings provide an opportunity for Police and Local Town and Parish Councillors to raise and discuss policing issues which are important to our Community. We are grateful to Devon and Cornwall Police, based in Camborne for their help and participation in these meetings.

Neighbourhood Plan

Carn Brea Parish Council started the process of developing a Neighbourhood Plan in 2017.

2017

- the 'designated area' is the whole Parish of Carn Brea
- an initial questionnaire was circulated to residents/businesses late 2017

2018

- a series of display events were held at locations around the Parish in March, April and May 2018
 - volunteers from the community came forward and the Carn Brea Parish
 Neighbourhood Plan Steering Group was formed

The members of the Neighbourhood Plan Steering Group are a combination of volunteers from the local community and Carn Brea Parish Councillors.

The Councillors act as the link between the Parish Council and the Steering Group.

The Steering Group had its first meeting in May 2018. From then onwards the Group have met monthly, set up the structure and administration of the group and its meetings, and set up 6 working groups based on the following topic areas:

- Infrastructure, Community Facilities and Services
 - Open/Green Spaces and Recreation
- Heritage, Conservation and the Built Environment
 - Housing Provision
 - Business & Retail
 - Traffic, Transport and Parking

These topic areas came forward from the responses received from the initial questionnaire which was sent out by Carn Brea Parish Council at the start of the process.

2019

- The Steering Group is working on producing a detailed questionnaire which will go out to all residents in 2019. Look out for this coming through your door.
- The Steering Group is consulting with local communities on development boundaries for the rural villages in the Carn Brea Parish area
- The Steering Group will be working on local landscape character assessments during 2019
