## **Dear Resident**

The Precept Carn Brea Parish Council has set for 2024/25 is £250,000 which represents a 13.1% increase (£11.08 for the year) on a Band D Property at £95.87 per annum.

The Parish Council started its annual budget setting in October and has rigorously reviewed all expenditure, plans and incomes. The precept remains the main source of income for the Council.

The Council owns and maintains approximately 22 acres of community land; this consists of Wheal Fortune and Moorfield Road Open Space. The Council also owns and maintains around 15 acres of heath at Carn Brea Hill and St Euny Well. Carn Brea Parish Council are in a Local Maintenance Partnership with Cornwall Council in which we arrange for the cutting of designated rights of way within the Parish and in addition the Council have a Management Agreement with Cornwall Council to maintain the land adjacent to The Square in Four Lanes and the Trevithick Monument in Station Road, Pool.

Subject to final agreement following public consultations in 2024, we are hoping to enhance facilities at Moorfield Road Open Space and Wheal Fortune Park which will be funded from existing reserves and won't be an extra burden on the precept.

Hanging baskets are erected and maintained within the Parish, and in 2023, as part of a 3-year plan, the Council purchased three Defibrillator units located in Pool, Piece and Pencoys which are available 24hours a day.

Following feedback the Council has received from residents regarding concerns of speeding traffic, the Council purchased a Speed Indicator Sign which will be rotated between various locations across the Parish to support driver speed awareness.

The Council also owns and maintains Treloweth Community Hall which also contains the Council's Offices. The Council employs a Clerk / Finance officer, Assistant Clerk and Admin Assistant along with a Caretaker and a Ground person who maintains and improves all Council assets in addition to litter picking throughout the Parish.

Several events are arranged throughout the year which includes Coffee Mornings, First Aid Training, a Community Awards Event, Remembrance Day, and the Council are working to reinstate the popular Carol Concert to the events Calander for 2024.

Carn Brea Parish Council produce a quarterly newsletter and have improved the distribution to reach more households in the parish.

In September 2023, and following years of hard work and dedication by the Neighbourhood Development Plan (NDP) Working Group, made up of local residents and Carn Brea Parish Councillors, the final draft of the NDP was submitted to Cornwall Council for final consultation and to an external examiner for review. A public referendum on approving the Plan is expected in Spring 2024. Before the vote we will circulate information about the Plan to our residents.

The Council have declared a Climate Emergency and have a working Action Plan which is regularly reviewed by the Council's working party, making recommendations to the Council on how we can further reduce our carbon footprint and launch new greener initiatives for the benefit of the community.

As a statutory consultee on planning applications, during 2023 the Parish Council considered and provided input on 75 applications.
