The Committee recognise there are concerns with the railings and support the Clerk in pursuing an appropriate resolution from the Company.

The Clerk also briefed the committee that quotations are being sought for quarterly and annual inspections by an external company and explained that the Grounds person is trained and qualified to carry out the regular visual checks.

### 24/11/OSI/10

To receive a report and cost estimate for the provision of a circular path with links from the entrances and to the public seating areas on Moorfield Road Open Space and consider next steps for the project, to include works specification making appropriate recommendations / resolutions.

An estimate and photographs of the proposed layout of the circular path (1.8m) were tabled at the meeting.

The meeting discussed the following considerations:

- Shortening the circumference of the path at the east end of the park area allowing for the provision of any future projects or park improvements.
- Shape and area of the path.
- Specific materials for path.
- Whether a cycle lane is required.
- Requirements from previous consultation: Dog only area off leads, Play Park, Gym equipment, fence.
- Goal posts relocation.
- The orchard area and if a path was required to Treloweth Way.
- That future improvements should be put on hold and assessed to prevent over filling the Open Space.

The meeting discussed that the preferred location for the path should be in front of the trees and benches on the north side of the park.

#### **Resolved to Recommend:**

That the specification for the Moorfield Road Open Space circular path with links to the picnic areas and entrances is as follows: that the path has a tanalised timber edge, that the path is made of an accessible surface, that the path is 1.8m wide, that the path runs inside the North tree line, that the path connects to Treloweth Way, that the path allow for an open space to the east of the park for future projects.
