To receive an assessment of land to be devolved and discuss appropriate strategies.

Cllr. Drew provided an update regarding queries from Cornwall Council regarding a piece of land at Carn Brea Lane. Maps have been supplied to Cornwall Council identifying the piece of land.

The meeting was supplied with assessments completed by the Head Groundsperson on possible pieces of land to be devolved. Discussions took place regarding several pieces of land and possible concerns.

St Andrews Churchyard Pencoys

Previous concerns had been raised regarding the Parish Boundary. Councillor Drew informed the meeting that the whole of the Churchyard is in the Parish of Carn Brea. The meeting was informed that the area of Churchyard for devolution is the area immediately around the church and will be a management agreement only.

Sculpture at Pool

The meeting was informed that there is meter on the land for electricity and anticipated that the Council should take over the land and the sculpture with responsibility for lighting the sculpture.

Trevithick Monument

The meeting discussed that inspection of the monument would be needed and painting of the lettering completed when needed.

Four Lanes Playing Field

The meeting was aware of significant concerns regarding Four Lanes Playing Field and expressed concerns regarding the cost involved. Concerns were raised regarding the possible underground waterways or pipes. Cllr. Sheppard and Cllr. Drew informed the meeting that they would attend the playing field to check the assessment produced by the Head Handyman. The Acting Clerk to obtain quotes for assessment of the land and proposed costs involved.

The meeting felt that an expert should inspect the playing field equipment and that Guinness Trust and Redruth Town Council could be contacted for possible contacts.

The meeting was informed that a representative would be attending the Full Council meeting in March to update the Council on the Green Infrastructure for Growth project.
