Cllr. Moyle informed the meeting that the contractor had reported four paths that need upgrading to two cuts as well as a path that has knotweed growing and that he is happy to continue with the contract for a further year.

knotweed growing.

18/12/PLA/9 To receive the tender specification for weed treatment within Carn Brea Parish and make appropriate resolutions.

Maps were provided to the meeting identifying areas treated for weeds currently by Carn Brea Parish Council.

Paths that need adding or extending were identified in Four Lanes.

A query was made regarding the treating of weeds at Station Road, Moorfield Road, the class A road from Barncoose through the industrial estate, the road leading to the traffic lights at Tuckingmill and from there to the bridge of the bypass across the road. It was agreed that the Clerk ask Cornwall Council to clarify how often weed treatment takes place at these locations.

Resolved to Recommend: That roads identified in Four Lanes be extended for

weed treatment. That Station Road be added if

Cornwall Council do not treat the area.
