# 18/06R/6 TO RECEIVE THE TERMS OF REFERENCE FOR THE REGENERATION AND PROJECTS COMMITTEE AND MAKE APPROPRIATE RECOMMENDATIONS TO FULL COUNCIL

# 18/06R/7 TO DISCUSS UPDATES TO BE MADE TO CARN BREA PARISH COUNCIL'S WEBSITE

Councillor Cousins informed the meeting that the Neighbourhood Plan list of meetings were out of date, GDPR information needed adding, the Beacon of Light event be added to the events page and that the book share information should be added to a tool bar on the left. Cllr. Cousins suggested that the Committee Chairs are responsible for checking that the relevant information on the website is up to date.

Cllr. Drew suggested that a Councillor be nominated to check the website on a weekly basis. Cllr. MacDonald volunteered to monitor the website and liaise with the Clerk to make appropriate updates.

### 18/06R/8 TO RECEIVE AN UPDATE ON THE FOLLOWING PROJECTS:

#### A) BUS SHELTERS

Cllr. Drew reported that an amended agreement for the transfer and maintenance of bus shelters in and around the Parish of Carn Brea had been received, with a total of 9 bus shelters on the agreement.

## B) PLAQUE FOR THE POOL POLICE STATION

Cllr. Drew reported that the plaque has been installed.

The meeting agreed that a local resident be invited to unveil the plaque with the Chairman of the Council. Cllr. Moyle agreed to contact the local resident.

### C) ST EUNY WELL

Stabilisation has been completed. The meeting agreed that before and after photographs be added to the Newsletter along with an appropriate write up.

#### D) NOTICE BOARDS

Cllr. Blakeway read a summary received from Cllr. Sheppard.

The notice board in Carnkie has been installed. Cllr. Sheppard is looking into the matter of door springs opening on occasions and has been supplied with keys which will be given to the office. The meeting agreed that a photograph be taken of the notice board with Councillor Hendry.

Cllr. Moyle reported that he had been in contact with the Clerk at Camborne Town Council regarding the shared notice board in Brea. The Clerk of Camborne Town Council will supply Carn Brea Parish Council with a key to enable the Council to place any relevant notices in the notice board.

The meeting agreed that this item now be removed from the agenda due to the completion of the project.

# E) ADDITIONAL NAMES ON WAR MEMORIAL

Cllr. Cousins reported that she has been in contact with Councillor Holmes and is awaiting a response with regard to information enabling additional names to be added to the war memorial.

# F) TELEPHONE KIOSKS

Cllr. Drew reported that the Telephone Kiosk at Piece has been completed and should be transferred to the Property Land and Assets Committee.

The telephone box in Carn Brea Village has been officially adopted. A pane of glass needs replacing, the telephone kiosk needs cleaning and painting. Three Carn Brea Parish Council stickers will need to be ordered once repairs and decoration have been completed.

A number of Councillors volunteered to complete repair work on 30<sup>th</sup> June 2018 once the Clerk has made appropriate enquiries regarding insurance.

Cllr. Hendry reported that the telephone box in Carnkie will be discussed at the Carnkie Community Group meeting on 16<sup>th</sup> June 2018 and he will report back to the next meeting of this committee.

#### G) MEMORIAL BENCH AT APPIN GARDENS

Cllr. Drew reported that he is awaiting a response from Guinness Trust to approve the installation of the bench.

## I) NEWSLETTERS

Cllr. Blakeway asked for an update from Cllr. Cousins regarding deadlines for submission of information to be supplied to the printers. Cllr. Cousins informed the meeting that the deadline was 17<sup>th</sup> June 2018. Cllr. Blakeway sought clarification on whether Cllr. Cousins and Cllr. Fielder wanted to continue to produce the newsletter and they confirmed that they did not want to continue. Volunteers were then sought from the committee to help with producing the newsletter. No volunteers came forward so Cllrs. Blakeway and MacDonald agreed to be the editors of the newsletter. Due to the short time frame to prepare information for the newsletter the meeting agreed to postpone the printing of the newsletter for one month.

# 18/06R/9 TO DISCUSS ARRANGEMENTS FOR THE REMEMBRANCE DAY SERVICE AND MAKE APPROPRIATE RECOMMENDATIONS.

The Clerk informed the meeting that the Parade Marshal, Father Peter, Brownies, Rainbows and the Redruth Town Band need to be contacted to make appropriate arrangements.

# 18/06R/10 TO DISCUSS ARRANGEMENTS FOR THE 100<sup>TH</sup> ANNIVERSARY OF THE END OF WORLD WAR I AND MAKE APPROPRIATE RECOMMENDATIONS

Cllr. Blakeway provided the meeting with a draft risk assessment outlining arrangements that are needed for the event.

Due to the number of volunteers needed the meeting discussed the possibility of inviting Redruth Town Council and Illogan Parish Council to join with the event and supply additional volunteers. The Clerk reported that to secure the order of the Beacon of Light, payment must be received before delivery.

Other possible arrangements were discussed and it was agreed that the Clerk make initial enquiries as to the availability of Redruth Town Band supplying a Bugler to play the last post.

That the payment of the beacon be paid upfront and that Redruth Town Council and Illogan Parish Council be contacted to request possible involvement and support for event.

# 18/06R/11 TO DISCUSS THE POSSIBILITY OF A BOOK SHARE IN AGAR CRESCENT AND MAKE APPROPRIATE RECOMMENDATIONS

The local resident proposing the book share in Agar Crescent addressed the meeting. It was explained that Cornwall Council would supply a licence to the resident for six months once public liability insurance of 10 million pounds has been arranged. Information was supplied on the table for Councillors.

# Cllr. Cousins left the meeting and returned

The meeting addressed that the proposed land for the book share is not Carn Brea Parish Council's land but is currently on the devolution list. The meeting was informed that the Council's insurers would not cover the project under public liability as it was not the Council's project or on Council owned land.

## Cllr. Cousins left the meeting

The local resident expressed the possibility of donating the book share to the Parish Council in order for them to install it but would like to volunteer to be involved in the running of the project.

Councillors were able to ask questions.

The meeting agreed to revisit the possible project once land has been devolved to the Council.

# 18/06R/12 TO DISCUSS CENTENARY OF WWI RECREATIONAL SPACES AND MAKE APPROPRIATE RECOMMENDATIONS

Cllr. Blakeway supplied information to the meeting regarding the Centenary Fields programme launched in 2014 and the criteria for recreational spaces. It was explained to the meeting that the deadline for submission of applications is 11<sup>th</sup> November 2018.

A discussion ensued regarding the short space of time to arrange for applications to be made, the need for a plan to erect a memorial on the proposed site and that the land must be owned by Carn Brea Parish Council.

A specification for works needed on the monument has been received and Cllr. Drew has been in contact with the owners of the hedge and they are happy for work specified to be carried out.
