CBPC Decision that Carn Brea Parish Council do not support PA21/03239 on the following grounds:-

- Contrary to Cornwall Local Plan Policy 1. The location is not a sustainable site. There is no public transport, no school, no shop, no public house, no place of worship and no play space with equipment for children. Access/egress will reply virtually exclusively by the car.
- The design of the proposed properties creates potential for serious loss of privacy, in particular to the east.
- The site is a serious flood risk. Local residents with intimate knowledge confirm the field acts as a soak away for excess water off Carn Brea. Policy 26 refers.
- Policy 27 Transport and Accessibly. The policy requires 'safe and suitable access' to a site. The characteristics of the site make access neither safe or suitable.
