### 23/01/A&P/08

The Clerk reported that contact had been made with the Council's solicitor regarding land registry of Rock Field and an agenda item will be added to April's committee meeting.

Planting has begun at the front of the hall and Cllr. Drew was thanked for supplying plants.

### 23/01/A&P/11

The Clerk reported that hanging baskets will not be able to be erected in Four Lanes due to being unable to gain permission to erect baskets on pylons.

### 23/01/A&P/14

The Clerk advised the meeting that the Climate Action Working Party had met and currently they are looking at collating the Council's carbon footprint and looking into ways the Council can offset their Carbon Emissions.

### 23/01/A&P/15

The Clerk reported that the proposed date for public consultation regarding Moorfield Road open space improvements would be 22<sup>nd</sup> April 2023 and that it would combine with a coffee morning.

The Clerk reported on the following:-

- Weekly, fortnightly and monthly tasks are up to date.
- Litter picking is being undertaken within the parish.
- Utility survey at Moorfield Road and Wheal Fortune will take place week commencing 24<sup>th</sup> April 2023 and the topographical survey will take place week commencing 1<sup>st</sup> May 2023.

The Clerk displayed a slide show sharing photographs taken over the last month which included Four Lanes Square improvements and benches within the parish.

The Clerk asked for consideration regarding the installation of planters at three locations within the parish and advised that there may be a small community group that may volunteer to maintain planters if the Council install them.

### 23/03/A&P/10

To receive an update on the provision of a physical Parish Newsletter and consider its future and make appropriate recommendations /resolutions.

The Clerk asked the committee to consider the future of the council's newsletter and the meeting considered the following:-

- Current distribution and the cross over with other parishes/towns.
- Approximately 175 properties within the parish that don't receive the newsletter.
- Paper format verses electronic newsletter.
- The use of the website and Facebook to disseminate information rather than the use of a newsletter.
- The need to gain public opinion.
- Using the Newsletter to consult residents as to how they would feel about moving from a paper newsletter to an electronic newsletter.
- Placing a note on the newsletter identifying that it is recyclable and encouraging residents to recycle the newsletter.
- How we would reach those who do not have access to a computer.
- Consideration of carbon footprint in relation to printing and distribution.
- The cost of producing a paper newsletter versus moving to an electronic format.
- Contacting the 175 properties that are not reached to signpost them to the website for viewing of the newsletter.

### Cllr. Jordan left the meeting and returned during discussion.

### 23/03/A&P/12

To receive an update on the Tree Planting Project and make appropriate recommendations / resolutions.

The meeting was informed that the Wildlife Trust had volunteered to assist during the project and following completion of the topographical surveys the sub-committee would meet.

The meeting was assured that consideration of appropriate trees for planting to encourage wildlife along with installation of bird boxes would be considered. Consideration of tree planting at Rock Field will also be considered.

Following a request by Cllr. Davis the meeting considered a request by a local resident regarding the area in Station Road in which two trees were previously planted. The meeting receive an update on the history of the site.

that Carn Brea Parish Council write to Cornwall Council requesting that if the two grids at Station Road Pool are not replanted with trees that they be removed and tarmacked over, due to them currently being a hazard especially to partially sited people.
