Steve Besford-Foster provided 2 documents for the group to review on the table relating to the Regulation 14 consultation responses.

Steve Besford-Foster went through the consultation survey results, reporting that when reviewing the residents' comments and the non-parish residents' comments and survey results, it shows that residents are significantly more positive for the plan vs non-residents.

Steve informed the group that these documents would form part of the evidence base that the examiner would review.

The group reviewed the Submission Draft R14 consultation report that was provided.

Strongest support was for the Landscape Policies and very positive that the community were supporting the plan, however as previously highlighted in the Survey Results, non-residents were not as supportive.

Key areas of concern highlighted by the responses were capacity for the area, affordable housing, maintaining the heritage of the landscape, facilities and transport.

Steve briefed the group on documents that will be required for submission including the consultation report — a working draft version of this was shown to the group specifically the Engagement & Consultation Strategy and work previously achieved.

The Response to Reg 14 will sit within the Consultation report.

The group also discussed the next stages and Regulation 16. Cllr Moyle suggested that the Parish Newsletter or a sperate leaflet could be used for the next stages to engage with the community to get key messages to the residents during the Cornwall Council consultation.

The group discussed the referendum stage of the process and Steve explained the process.

The consultant explained that the Steering Group remain until the referendum. For the referendum, a campaign group can be formed.
