The consultant Steve Besford-Foster updated the group on a recent call with

AECOM the previous week on the updated version of the Design Guide. Additional photographs to be added which will be provided by Cllr Glanville

Once these areas completed, the Design Guide will then go through a period of consultation. Suggested that this is completed in tandem with the Cornwall Council Consultation.

Equalities Impact Assessments

A copy of the final draft Equalities Impact Assessments Stage 1 and Stage 2 were provided for the group to review, and Steve talked through the documents ahead of the assessments being submitted to Cornwall Council as part of the plan submission documents.

Steve made specific reference to the updated Baseline Data in Stage 1 which now included up to date 2021 census data information.

Stage 2 of the assessment was reviewed, and Steve briefed the group on each of the sections.

Steve requested that the Steering Group approve the final draft Equalities Impact Statements Stage 1 and Stage 2.

Resolved: that the draft final Equality Impact Assessment Stage 1, Carn Brea Neighbourhood Plan 2023 – 2030 and the draft Equality Impact Assessment Stage 2, Carn Brea Neighbourhood Plan 2023 – 2030 are approved for submission to Cornwall Council.

The meeting agreed that the Clerk would submit both documents along with the Consultees List that was requested by Cornwall Council.

Next steps:

Steve briefed the Steering Group on the next stages following submission of the Draft Neighbourhood Plan and discussed next steps heading to referendum.

During the 6-week consultation period, an examiner is appointed. The plan is reviewed by the examiner to ensure it meets the basic conditions. The examiner reviews the responses received.

The examiner will produce a report and recommend that the report can be submitted to referendum without changes, with amendments or that it does not move to referendum if it fails to meet the basic requirements.

Steve went through the examination process and the referendum process and the regulations and process for promoting the campaign / referendum.
