25/003 Chy Karenza North Pool Road Illogan Redruth Cornwall TR15 3JQ
PA25/09303 Alteration and retention of existing dwellings.

Resolved: that Carn Brea Parish Council unanimously object to PA25/09303 on the grounds that if supported, it would give the applicant 3 years to start compliance with no completion date guaranteed, therefore avoiding compliance with previous enforcement notices or decisions of appeals inspectors.

We also note inconsistencies and inaccuracies in the application as regards the plans submitted for the current site showing the original bungalow. The development is in a critical drainage area however, on the application form, under Foul Sewage, an answer stating 'unknown' has been given to the question are you proposing to connect to the existing sewage system, and there is a lack of provision for waste and recycling as required in the Cornwall Design Guide Appendix 2, S2.1. Additionally, Carn Brea Parish Council object to this application on the following grounds: it is contrary to Policy H6 of the Carn Brea Parish Council NDP, on the grounds that the proposed dwellings are not proportionate to the original dwelling and fails to respect the existing relationship with adjacent buildings and Policy SEC1 In the Climate Emergency Development PD requests that onsite renewable generation with a preference for roof mounted Solar PV .
