One resident expressed objections to planning application PA25/01421, citing concerns over the proposed height, loss of privacy for neighbouring properties, incompatibility with surrounding single-storey dwellings, removal of an essential tree line and potential risk of subsidence due to nearby mine shaft. The resident

indicated they would be supportive of a single-storey development.

The applicant for planning application PA25/05882 addressed the meeting to outline amendments made in response to the Council's previous comments. The applicant explained that the revised proposal aims to be in keeping with the surrounding area and incorporates energy-efficient measures.

25/050 Land Adjacent To, Lazy Acre, North Pool Road, Illogan, TR15 3J PA25/01421 Erection of detached building comprising ground floor garage with annexe above.

## Resolved:

that Carn Brea Parish Council unanimously do not support this application on the following grounds:

- The design and character of the proposed building is not in keeping with the local vernacular, ie. all the surrounding properties are bungalows and the proposed building is two stories, Contrary to the Cornwall Local Plan, Policy 12, Design.
- The design and character of the proposed building will result in overlooking and unreasonable loss of privacy to the neighbouring property, Contrary to the Cornwall Local Plan, Policy 12, Design.
- The design of the proposed building is not informed by and consistent with the scale and character of the surrounding area, and does not reflect the scale and roof line of adjacent buildings. This is contrary to the Carn Brea Neighbourhood Development Plan, Policy D.3, Design, Development Standards and Regeneration.
- We note that the internal design characteristics of the first floor living accommodation are such that it could be a completely separate dwelling and therefore potentially not an annexe or subservient to the main dwelling.
- We note that the original Planning Permission for Four Jays, the main dwelling, granted by Kerrier District Council in 2004, required Four Jays to be single storey to match the surrounding properties and that trees be planted, and maintained, for screening purposes around the property.
- If built as proposed and the tree belt removed the development will be seen from residents in Illogan Parish to the north with loss of amenity to them.
